Each of the Activities above is counted as one activity each, and is tracked through a report that CA will run at the end of the six weeks. Once someone has been identified as completing the ten activities, they will receive a badge to notify that individual of their completion. One entry permitted for each person, so using more than one email address would not be permitted. Finish this multi-course competition and you will be eligible to win an iPad mini or Jawbone wristband. The contest will begin on September 22, 2014 and end on November 6<sup>th</sup>. Those who complete the decathlon will be placed into a raffle which will be take place on November 7, 2014. See the attached eligibility rules.

The CA Community Decathlon for Community Members (the “Contest”) is a Random Drawing Contest for those have completed the requirements for the Community Decathlon. Please read the Official Rules below in their entirety.

#### **ELIGIBILITY**

This six winners will be selected through a random digital selection process the first three winners drawn will be awarded the Apple iPad Mini 16GB and the fourth through six winners will receive the Jaw Bone wristband . Odds of winning depend upon the number of eligible participants who complete the decathlon.. Any person who has completed decathlon will receive a badge electronically so that they are aware of their completion. The Winner will be notified at the conclusion of the Drawing. If the potential Winner cannot be contacted or does not respond to CA’s contacts, through no fault of CA Technologies, within ten (10) days after the first attempt, an alternative Winner will be selected at random and the same procedure will be followed until a Winner is established.
