Existing Identity Suite customers should strongly consider updating their deployment for the many benefits that this new release can provide.



New Capabilities In This Release:


Virtual Appliance platform:

CA Identity Suite 14.0 officially introduces the CA Identity Suite virtual appliance. The virtual appliance is a complete operational platform that allows implementers to setup a production-ready, highly available, deployment using drag & drop interface in minutes. The platform eliminates the traditional installation phase and streamlines other on-going administrative tasks such as adding/removing capacity, implementing upgrades, provides service monitoring, collecting logs across clustered machines and more (The virtual appliance packaging will be available in the next few days).



DeploymentXpress:

The DeploymentXpress is a new capability included in the CA Identity Suite. It provides a use case marketplace, allowing implementers to deploy end-to-end, pre-configured, best-practice business use cases in just a few clicks. The use cases are based on CA's experience with hundreds of large-scale enterprise deployments. Customers using this capability can see a dramatic time-to-value improvement.



Privileged Access Governance:

Privileged Access Governance introduces a granular integration between CA Identity Suite and CA Privileged Access Manager (CA PAM). The integration addresses the need for consistent governance processes across privileged and regular access. It includes Access Certification, Access Request and Provisioning/De-provisioning for privileged access.
