Based on the revised focus of CA World, the IUA board of directors, together with Computer Associates, has evaluated how to offer best alternatives for IDMS-specific educational sessions which traditionally have been available to CA World attendees.

Here are the major impacts:

- The IUA 2001 Workshop will be expanded by one day to provide additional educational opportunities for the IDMS community. The Workshop will begin Sunday morning, October 14 and extend into Wednesday afternoon, October 17.
- CA has generously agreed to provide speakers to present a significant number and variety of topics to IUA 2001 Workshop participants. In addition to the robust DBA track, a special emphasis will be placed on topics of interest to applications developers. Once again, the popular Web track will be offered. Details will be posted at iuassn.com as soon as they become available.
- The registration fee for the four-day conference has been increased to cover the additional costs associated with extending the workshop by a day. However, at \$399 for early registration (\$449 after October 5), it still represents an excellent value for top-quality IDMS education.
- Additional opportunities for networking will be provided. Many of the day's presenters will be available in the late afternoon so that attendees can ask questions and get additional information. Also, attendees will have increased access to vendors each day to learn about the latest products and services for the IDMS community.

● REGISTRATION NIGHTMARE LEADS TO WEB-ENABLED DREAMS

Northern Arizona University streamlines their usage of IDMS with LOUIE

Imagine trying to register around 12,000 college students in a packed field house with long lines, short tempers, crashing software, and an electrical outage. Unfortunately, Northern Arizona University (NAU) has experienced all of the above which prompted the college to start thinking about streamlining their registration process.

NAU installed IDMS in 1984 to support the student information system that was acquired from their sister university, Arizona State University. Since its installment, IDMS has served NAU well. And now, with recent changes in the IDMS Web-enabled registration process, NAU has had less traumatic registration incidents.

Before IDMS, registration at NAU used to consist of students obtaining punch cards for each class and a punch card containing the student's name and other pertinent information. The IDMS registration application allowed NAU to rid themselves of the punch cards. Students have one piece of paper containing all necessary registration information, which is given to a data entry clerk.

The new Web-enabled registration process is called LOUIE (Lumberjacks'* Online University Information Environment) and so far it has been well received. An anonymous student wrote to NAU, "The LOUIE system is working out great for me since I am a student in Phoenix. I think its great being able to drop and add everything I need for summer school or for statewide classes right online. Keep up the good work!"

"NAU has improved its service to the student many times over by Web-enabling the registration process," said Keith Vogler, NAU Database Administrator. "Giving the student the ability to add/drop a class, pay fees, and check on the availability of classes is a huge bonus."

To change their registration process, NAU took these steps:

- Revised University enrollment policies and procedures
- Analyzed and developed protocol methodologies, which allowed communication between MVS and Web servers
- Developed self-service, user-friendly applications while complying with legal and security issues
- Established back-end programs that supported complete units of work

Regarding the implementation of the IDMS registration process, Vogler said, "Although it may be difficult to find employees with IDMS experience, they can become very effective users of the product once they are trained."

● IDMS DARS AND YOU

A clear responsibility of the IUA board of directors is to represent the IDMS community to Computer Associates. One way this is done is by submitting Demand Analysis Requests (DARs) to CA. CA recognizes that DARs coming from IUA reflect all the member companies that IUA represents. This gives more weight to DARs submitted through IUA than those submitted by any single company.

At least once a year, IUA creates a ballot of all current DARs. These are then posted for voting by the entire IUA membership. Once tabulated, the ranked listing of DARs are given to CA to be evaluated, and if possible, incorporated into the next release of IDMS.

Although submission of a DAR through IUA does not guarantee that CA will put it into the next release of IDMS, it does help. Here is a list of the DARs incorporated into Release 15.0 of CA-IDMS:

QUESTIONS AND ANSWERS

Note: The following reflects actual questions posted on IDMS-L and the corresponding answers. The proposed solutions contained herein have not been tested for accuracy.

Question: One of our clients would like to identify from within a link to dialog what dialog it is being linked from. Is this information somewhere that can be captured?

Answer: Try ACCEPT HIGHER DIALOG INTO variable. After execution the variable should contain the name of the dialog that issued the link.

Question: My question is simple but requires greater knowledge of IDMS than I have. I can spell it correctly....most of the time. With that, my question addresses the EXTERNAL parameter in RHDCSRTT. Given the following example:

#SECRIT TYPE=ENTRY,  
  RESTYPE=SGON,  
  SECBY=EXTERNAL,

  EXTNAME=(RESNAME)

When EXTERNAL is specified, is the call direct to the security product or indirect via a tool such as ENF?

Answer: IDMS External Security routes security checks to CAISSE, which in turn calls the security product. CAISSE (a sub-component of the CA90 Services) routines are loaded in CSA and they bear no relationship to ENF address space.

Question: Has anyone looked into IDMS SERVER SQL performance against a network structure? Could you please share any techniques, which improved performance?

Answer: We mounted a major exercise on this. Steve Cannon of CA provided invaluable help and guidance, and the listserv contributed too. Worth considering are:

- Have CCITCP and ENF running non-swappable in a high performance group
- Upgrade to IDMS Release 14.1 and Server 4.2 if you are not there already
- Define RUNUNITS for SQL security
- If you are using dynamic SQL, minimize the amount of dictionary navigation by defining a tailored Accessible Tables view limited to the records you actually need. In addition, spruce up the dictionary by weeding out superfluous items and then unloading/reloading

- Provide generous buffers for the dictionary/ies
- Numbers of record occurrences per table are not maintained automatically for non-SQL databases, but estimates can be manually recorded on schema records. These influence the database navigation upon which the SQL engine decides, so it is worth making sure these are reasonably accurate.
- GI36756 describes a more convenient way of finding out what your SQL is actually doing, as opposed to what you think it ought to be doing.
- Table Procedures are a lot faster than dynamic SQL, because they eliminate 99% of the dictionary navigation. This is particularly noticeable with single-record retrieval, when this produces most of the response delay. They can also compress what might be several SQL calls from the application into a single one, just like a conventional RDBMS remote procedure call, and save most of the to-ing and fro-ing.
- If you are using Quickbridge, have a close look at the COBOL source it produces, and check that the navigation defined is optimal, particularly when retrieving a keyed record. If a record is held CALC on an application-allocated key, but is ordinarily accessed with a symbolic key via an index, Quickbridge needs guidance to use the latter rather than an area sweep.

Question: Does anyone have a program to rebuild user owned indexes on MVS?

Answer: Such a program can be found at:

Question: A batch job was running under CV doing updates. Apparently, too many without any commits. A journal offload job was started and made it as far as the message "OFFLOADING PROCESS COMPLETE". The journal job then became hung as well as the batch update job (and I think other non-IDMS batch jobs as well). By the time I found out what was going on the System Programmer had canceled the journal offload job! After this, the batch update job was canceled. However, it did not roll back because CV is still trying to condense the journal. The message DC203004 is being continually written to the system log (J1JRNL BEING CONDENSED - WAITING FOR FINISH). I tried to run IDMSAJNL with OFFLOAD=RESTART but it abends with a U2110

(JOURNAL FILE WAS NOT OFFLOADING OR CONDENSING). Where do I go from here? The database itself is not as big a concern because a backup was performed right before the update job ran and the online task was disabled. But how do I get the journal situation straightened out? By the way, this is a 10.2 CV. I would greatly appreciate any help?

Answer: I too have been caught with a journal job canceled by an operator because it was hung for what ever reason and left the journal file in an unloadable state. Pretty much the only way out is what you had to do, format journal file. Then you pray and keep your fingers crossed that you don't need that file for a recovery.

Question: I have a question on predefined system run units. We are running 14.1 SP2 on OS/390 2.8. I have defined two LOADERS for secondary dictionaries/load areas but when I display the run unit loader for the system loader (sysgen def count for LOADER is 5) it always shows the same count of allocated as overflows. This is the system run unit loader display:

Why am I getting the same for allocations as overflows? Is this bit bucket maybe wrong?

Answer: It looks as if none of your dedicated is being used—all are dynamically allocated? Do you have ANY dictname/dbnames that anyone could set that is NOT

represented by a LOADER pru? The prefix on the PDE is a function of the dictname/dbname, NOT the actual load area used—thus if you had (for whatever reason) five dictnames that point to the SAME loadarea, you would need five different PRU's to avoid any overflows being passed to the default loader PRU. In addition—if APPLDICT is your default dbname, all loader RUs that execute against APPLDICT as the IMPLICIT dictname would go to the 'null' pru. But all loader RUs that execute against APPLDICT set explicitly, would go against the APPLDICT pru.

Question: Our company is currently using IDMS Release 14.1 with DMLO installed. The development teams would also like to use OLQ for increased data viewing capabilities. Would anyone have a list of the advantages/disadvantages that OLQ can provide over DMLO? Alternatively, are there any issues or concerns that could be encountered by using both products?

Answer 1: The best advantage for OLQ is that developers cannot update the database. We use both products for developers in a test environment. However, only the DBA staff has DMLO authority in production.

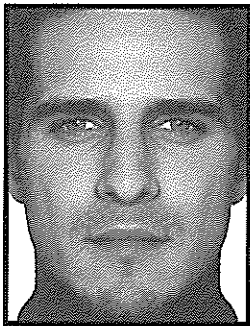
Answer 2: OLQ can be run in batch, is read only. DMLO includes use of lists, macros, user profiles.

Answer 3: DMLO is "conversational." That is, DMLO can hold locks for long periods of time. Think of a TSO/ISPF user sitting in an hour-long ISPF edit session on a piece of JCL. This is conversational. The edit user holds the equivalent of a DISP=OLD enqueue on the data being edited. Now, think of a DMLO user, in shared update, retrieving a highly accessed OOAK record in a production database. Locks that should be released won't be as the DMLO user peruses the record in "human" time. Imagine what might happen if a DMLO user left for lunch in this situation. OLQ, being read-only, is preferred for simple development checking.
