## accessing multiple MUFs in batch

- new URTs
  - VPE checks for Global URT (SIDNAME used)
  - VPE sets MUFS=YES, RRS=YES
  - VPE notifies \$DBC FUNC=OPEN caller
- affects DB2 in mixed environments
- requires VPE 11.0 for z/OS batch
  - new path for \$DBC
  - 2-phase COMMIT process available
  - if VPE has turned on RRS, CA Ideal uses it



## **URT for multiple MUFs**

```
DBURSTR TXNUNDO=YES, MULTUSE=YES, SIDNAME=SIDA11QA

DBURTBL DBID=010, TBLNAM=CUS, UPDATE=YES, SYNONYM=YES

DBURSTR TXNUNDO=YES, MULTUSE=YES, SIDNAME=SIDA11DV

DBURTBL DBID=018, TBLNAM=CUS, UPDATE=YES, SYNONYM=YES

DBUREND SYSTEM=OS
```

- VPE provides the equivalent of DBURINF

END



## **URT for multiple MUFs**

- access multiple instances of the same DB

```
URT TITLE 'QA R11 TEST'

DBURSTR TXNUNDO=YES,MULTUSE=YES,SIDNAME=SIDA11QA

DBURTBL DBID=010,TBLNAM=CUS,UPDATE=YES,SYNONYM=YES

DBURSTR TXNUNDO=YES,MULTUSE=YES,SIDNAME=SIDA11DV

DBURTBL DBIDUSER=910,DBIDMUF=10,TBLNAM=CUS,UPDATE=YES,SYNONYM=YES

DBUREND SYSTEM=OS

END
```


ASSIGN DVW CUSTOMER DBID 910



#### PARM='IDENTIFY'

- allows non-Ideal subprograms to use the EP 'DBNTRY' in VPE instead of the one in their own URT
- no separate URT for subprogram
- must include all tables in shared URT
- URT will be opened by VPE 1st access from CA Ideal
- non-Ideal subprogram
  - must NOT make OPEN/CLOSE calls
  - not linked with URT
  - AMODE(31) because DBNTRY is above the line.





## **Table Partitioning**

- unique CA Ideal feature
  - RUN existing apps against a partition
  - RUN existing apps against "ANY" set
- ASSIGN syntax
  - ASSIGN DVW xxxxxxx TABLE yyy
    - · command as above
    - statement needs quotes around literal value, can use fieldname (e.g. run parameter)
- URT implications
  - new table id must match URT value



# \$functions

- \$APPL-ID
- \$HOST-ID
  - may have same value as \$USER-NAME or \$USER-ID
  - may only match an ALIAS
- \$PROGRAM / \$SYSTEM / \$VERSION
- \$UPCASE
  - uses PMS translate table
- \$DATE ('ISOWEEK', ...)

### **Change Managers**

- e.g CA Endevor
- DSF "utilities" to check STATUS, COPY-VERSION etc.
  - could be written in Ideal
- make sure @IIDSYSF is linked as 'REUS'
- be careful with panels
  - may need to promote with programs
  - do not move source and object
- PROD and VERSION
  - may mean different things to CM product



### IF...THEN...ELSE...otherwise...

```
IF YEAR < 80

SET CENTURY = 20

ELSE

SET CENTURY = 19

ENDIF
```

— What if YEAR is missing (null)? Better to code as SELECT

```
SELECT YEAR
WHEN NULL
SET CENTURY = 0 : (or NULL as applicable)
WHEN LT 80
SET CENTURY = 20
WHEN GE 80
SET CENTURY = 19
```



## always/never

- ALWAYS release a program after calling it to minimize memory use
- NEVER release a program after calling it, because you will cause extra
   I/O to reload it if you call it again



### Web DIAL and DEBG transactions

 modify usual URL by inserting two extra "path nodes" at the beginning

/DIAL/dialcodes/...

or

/DEBG/member/...

- "..." is the rest of your usual URL, e.g. IDW3/DEMOMENU
- TCPIPService must use the IDLWBAD3 urm which sends these to SC00WBDD instead of SC00WBTD



## **VLS** security

- protect VLS libraries from non-VLS-aware programs
  - TSS PERMIT(acids) DSN(vlsfile.dsname) -
    - PRIVPGM(IDBATCH IDUTSTRN IDUTOTRN IDUTILTY VLSUTIL) -
    - LIB(ideal.loadlib.dsname) ACCESS(UPDATE)
- similar functionality in ACF2 and RACF.
- prevents library corruption
- use is authorized through accessing program
