### What is CA Test Data Manager?



### **CA Test Data Manager**

Builds Test Data at the Speed of Agile by:

- identifying your existing test data and
- Generating missing test data for complete coverage – <u>synthetically</u>, <u>virtually</u>, <u>and</u> <u>compliantly</u> (supports GDPR+ other regulations)

Fast and Efficiently

### Challenges:



Lack of test data delays testing: Teams can wait days or weeks for the right test data to be located or manually created



Inefficiency: 70% of all test data creation is done manually – unfit for the speed & velocity needed in agile

#### How We Do It:



- 1. Complete Test Data Solution: Masking/subsetting, synthetic data gen, find and reserve, virtual data
- 3. Compliance Tools: Locate existing PII data and flag for remediation with heat maps & reports

#### 2. Admin/Tester Friendly Portal:

Locate, generate, manage test data from a test data portal

4. Agile Testing: Deliver testers with high quality test data for maximum coverage within a sprint

### CA Test Data Manager Personas




#### Director of QA/Test

#### Director/VP of Compliance

### Test Data Engineer

I'm looking for patterns in the requests for test data from the Director of Test. I'm concerned about getting the right data to him/her and must be able to communicate my needs to the Ops person.



#### Ops/DBA

I'm the gate keeper for the production data. The more easily I can gather the right data for the Test Data Engineer, the more I can focus on other areas of my job. I want to be able to pull data quickly to minimize the impact of frequent data requests.

### Yahoo

- 1 Billion accounts compromised!
- Names, email addresses, passwords and other data was leaked

### **Equifax**

- Affected 143 million customers in the US & Canada
- Names, addresses and social security numbers were compromised



### Deloitte

- Breach leaked emails, passwords and personal details of high-profile clients
- Ironically, Deloitte provides cyber security consulting services!

- Data use restricted for testing and pre-production systems; strict breach reporting requirements







