reliability, excellent customer service, and valuable deliverance, Sallie Mae wanted to implement the convenience of Web self-service opportunities to students and schools on top of its already premium offerings.

To complement loan queries via phone, Sallie Mae imagined a call center for lenders to have the accessibility to view their loan activities and services online. The deterrent was this: "Can we find a bridge that will bring these new systems and our core loan management application, EAGLE II, together?"

A bridge is exactly what Sallie Mae needed — specifically the IBM CICS Transaction Server 3270 bridge.

"An object-oriented approach was used to implement the system. The development team designed object and method programs to drive the existing CICS-IDMS application programs," said Mark Smith, Sallie Mae Business Technology Advisor. "Each method represented a business process that is performed by one or more screens. Each object used a similar interface, so the objects and methods could be reused by both the external Web application as well as the internal call center application."

Sallie Mae has used IDMS for more than 20 years and did not realize CICS could help them use IDMS in a new way until now. CICS was never marketed as a product to help Web-enable IDMS applications. To Sallie Mae, CICS was the gateway between open systems and mainframes that saved time, money, and human resources.

"We were able to leave primary technical people to their normal duties while bringing in less experienced people, who didn't need to know the business, to make the updates on IDMS," said Smith.

Smith attended a conference that provided the original idea (of bridging the systems), performed some research, took a risk, and made the concept work for Sallie Mae.

"Many database administrators (DBAs) think they know all there is to know about IDMS and its capabilities," said

Smith, "but little do they (DBAs) know, there is something new and exciting that CICS can help IDMS do."

So instead of accumulating high costs in developments of a new system, the bridge allowed Sallie Mae to save money. Using appropriate human resources and research was an easy way to convert a current product to something newer and better.

End results of installing the bridge: Sallie Mae had approximately \$10 billion in new education loans last year, almost an 11% increase from the previous year.



QUESTIONS AND ANSWERS

Question: Our two largest areas occupy over half a pack each and are both filling up fast. The user is reluctant, to put it mildly, to offload any data. I'm in the process of splitting these areas into multiple files on different packs; each pack with it's own buffer. I've read the manual to figure out how to do it, but does anyone have any "rules of thumb", caveats, or gotchas on this subject?

Answer 1: Besides the obvious solution of changing all of your DMCL load modules to now referencing two files instead of one, and all start-up and locally running JCL, the only gotcha I can think of is to remember to now include the new dataset in any backup and recovery JCL or procedure you might have.

Answer 2:

1) What is the dominant LOCATION MODE of records within the areas? CALC or VIA? If CALC, you will probably want to split your areas up by using an unload/reload. If VIA, you could use the EXTEND FILE. Actually, you could use EXTEND FILE in either case; however the original CALC page range will be maintained.

- 2) Have you looked closely at the current page size of the areas? What kind of volume do they reside on? 3380 or 3390? Is the page size "device optimal" for the device upon which it resides? Also, look to see if there are any logically full pages currently present in the areas. Why? Maybe a simple EXPAND PAGE will buy you some time to reconfigure the files/areas.
- 3) Having an area in multiple files offers only a small performance advantage in the course of normal processing, where some speed advantage can be had is in utility processing. For example, backups, FORMAT FILE, and PRINT SPACE. Basically, any utility that can be run under BCF at the file level can now run in parallel (multiple jobs, each processing a file instead of an areas).
- 4) Breaking an area up into multiple files can be done with the BCF BACKUP utility alone. Here's how:
- a) Backup the area with the "Old" view one file, one area.
- b) Restore the area with the "New" view Multi-file, one area.
- 5) As another poster mentioned, if your site is using dynamic allocation, the change should be transparent. If you are not using it, JCL will probably have to be changed. Also, ensure that your site backup/restore will include the new files.



Question: I have a question regarding "Found in Buffer" hits. For six days, I tracked my buffer hits. I then averaged the DCMT command results for the six days and it is 84.5%. I have 13 buffers defined to IDMS of varying page sizes and number of pages. I do not use pre-fetch and these stats are mostly from on-line activity although some batch is included (08:00 - 17:00). The formula I used was (Found-in-buffer)/(Found-in-buffer + Phy-reads). My question is basically "How good is 84.5%?" Are other shops higher or lower than this percentage? I know that I will be reducing the number of buffers and increasing the number of pages but I'm trying to get a feel of just how good/bad KSU is at this point in time. Anyone have some information that could shed some light on this question?

Answer: I cannot begin to tell you where I learned/heard this "rule-of-thumb", but I have it stuck in my brain that an 11:1 ratio (or a corresponding 11/12 fraction = .916667) is the "ideal" mix of logical and physical database reads.

Question: I have several IDMS systems running on one LPAR. One of the systems is receiving a warning that the LMP codes are going to expire, but this only happens once in a while. The systems are all running on the same LPAR and I have not seen this on any other system. The last time it showed up was Nov. 4; we cycle this system once a week and it has not showed up again since then. Any ideas would be appreciated.

Answer: Typically the LMP Key warning will only appear when the product code is being used. For example: If OLQ has expired, then the warning will appear when someone attempts to utilize the function. The warnings will also appear at the system startup for those product codes being used by the startup routine. For your problem: discuss this with your systems staff. They may not have the current copy of your LMP Keys in their CAI libraries. Since the warnings are intermittent, I would suspect a key for a product not used very often, or the systems staff is accomplishing IPL's with different CAI libraries.

Question: We have just completed our upgrade from 12.01 to 14.1. We would like to use DBNAMES with mixed page group segments. Does anyone have experience with rununits that have mixed page group areas?

Answer: We installed 14.1 late last year and started using mixed page group support in production earlier this year. With the exception of a few problems, which have been corrected by APARs, we have been very satisfied with this feature. Make sure that you have ALL mixed page group support APARs applied to your system, including LO69345, LO72698, and LO82089. Our first step in implementing mixed page group support was to identify programs that issue an unqualified db-key request. We requested a 12.01 version of LO44807. CA wrote a test APAR, which is published as LS52053. Programs identified were reviewed and updated per the 14.1 features guide.

We started off slow by first moving related areas to a new segment and moving the entire segment to a new page group without making any page range changes and making the appropriate changes to the DBNAME table. Programs accessed the two or more page groups without incident. Next, we performed unload/reloads to reconfigure the areas in the new page group, which resulted in overlapping page ranges. This has also worked without any problems. A year ago at this time, we spanned approximately 803,390 volumes and had less than 200,000 contiguous free pages in page group zero. Today, we have grown to over 1,603,390 volumes with plans to add 50 in the first quarter of 2001 for growth. Page group zero has over seven million pages free with the largest over 800,000. Without the mixed page group feature, this would not have been possible.

Question: I need to expand an index area with several indexes that are defined as DUPLICATES LAST. To the user, the order is important and the index works properly because chronologically the latest duplicate ends up at the bottom of the list on a read. When I expand the area and the index is rebuilt, the duplicates are stored back in index order by what appears to be DBKEY and the chronological storing of "last" that the users saw previously is lost. The data looks out of order to them but by definition it is correct. Is there a way to expand the area and keep the duplicates in the initial order of duplicates last, as they were originally stored (without writing special programs to offload the data)?

Answer: Excellent question. Be aware that it is the rebuild of the index, not the expand of the area (if it was an X-Page) that reordered your duplicate keys. Was it an X-Page or are you using the word "expand" generically? One way to ensure duplicate order in an index is to:

- 1) Do a REBUILD FROM INDEX
- 2) Add the \$ORTPARM (or DFSORT equivalent) to the IDMSBCF step. As the sole in-stream parameter code: EQUALS.

For example:

/\$ORTPARM DD * EQUALS

The "EQUALS" parameter will preserve the input sequence of duplicated "key" values. The EQUALS /NOEQUALS default can be varied by installation. EQUALS might be the default setting at your site.

Question: I can't get the system to recognize the first file assignment. I copied the syntax out of the manual (first mistake). Can somebody tell me what I'm doing wrong? I get the 1 through 100000 not assigned, under the second file, no matter how I describe the file assignments.

Answer: Syntax must be:

CREATE PHYSICAL AREA DOCSEG.OMMEDSP-AREA PRIMARY SPACE 200000 PAGES FROM PAGE 5100001

MAXIMUM SPACE 200000 PAGES PAGE SIZE 13680 CHARACTERS WITHIN FILE FILE-OMMEDSP1 FROM 1 THRU 100000 WITHIN FILE FILE-OMMEDSP2 FROM 1 THRU 200000;

Assignment is for the file for a number of blocks. This is to allow for multiple areas assigned to the same file.

Question: I have a question regarding the syntax for sending messages in batch. We tried sending using this syntax: SEND A 'AT 3:00 P.M. E.S.T. YOU WILL BE LOGGED OFF 'IMM. The IMM is for immediate, however it didn't seem to send it right away. Am I using the correct syntax? We do have the: SET OPTIONS INPUT 1 THRU 72 in front.

Answer 1: Put the IMM before the message:

SEND A IMM 'AT 3:00 P.M. E.S.T. YOU WILL BE LOGGED OFF'

Answer 2: Here are a couple of other related comments regarding sending mass messages to terminal users via Ucfbatch:

- Make sure your online task definitions use the "SAVE" option. This will preserve the user's work that they were doing when interrupted by the blast message, and return their screen to them uninterrupted after they've read the message.
- The Lterm has a "Break/Nobreak" parameter. If the Lterm's are set to "nobreak", then the user's work will not be interrupted immediately with the blast message. The message will be queued to their terminal and will wait for the next opportunity to be sent to that user, without interfering with the current work.
